General Functions:

IOM Turkey is operating in a complex migration environment. The country is hosting over 4 million of migrants and refugees under various administrative status. IOM Turkey supported developing migrant integration policy and is implementing capacity building programs aiming at social cohesion of migrants in the country and strengthening the capacity of authorities at central and local levels. The incumbent under the direct supervision of the National Program Officer and overall supervision of Emergency Post Crisis and Transition Coordinator, will support the implementation and further development of the harmonization portfolio under the Migration Management Department of IOM Turkey.

Major Duties and Responsibilities:

- 1. Coordinate the implementation of the project; monitor implementation of the activities to ensure work is proceeding according to established plans; analyze implementation difficulties and make recommendations for adjusting implementation modalities and work plans to best reflect changing environment on the field.
- 2. Regularly research, follow-up, compile, analyze and present information/data on national, regional and international developments, reports, legislation and other relevant documentation, highlighting noteworthy issues for the consideration of appropriate parties.
- 3. Monitor budget expenditures; verify availability of funds and maintain a proper record of approved project budgets and their revisions.
- 4. Coordinate and monitor the financial, administrative and technical aspects of the project in line with IOM policies and donor requirements.

- 5. Plan, coordinate and conduct capacity building workshops for relevant internal and external parties.
- 6. Participate in meetings and conferences; maintain effective liaison and coordination with local authorities, partners, United Nation agencies, intergovernmental and non-governmental organizations, donors and other stakeholders relevant to the project.
- 7. Coordinate the preparation of correspondence, briefing notes, presentations, narrative and financial reports; ensure status reports are prepared and submitted in a timely manner.
- 8. Identify and document good practices and lessons learned; contribute to the development of Standard Operations Procedures (SOP), policies and concept papers and support the development of new projects.
- 9. Supervise and provide guidance and training to reporting staff.
- 10. Perform other related duties as assigned.

Required Qualifications:

Education:

- High School diploma with seven years of relevant experience; or,
- Bachelor's degree in Political or Social Sciences, International Relations, Development Studies, Migration Studies, Human Rights, Law or related fields from an accredited academic institution with five years of relevant professional experience.

Experience:

- Experience in liaising with governmental authorities, national/international institutions, United Nations agencies and non-governmental organizations;
- Experience in working with migrants, refugees, internally displaced persons, victims of trafficking and other vulnerable groups; and,
- Prior work experience with international humanitarian organizations, non-government or government institutions/organization in a multi-cultural setting.
- In depth knowledge of the broad range of migration related subject especially social cohesion areas.
- Minimum 3 (three) years of experience in social cohesion related areas.
- Experience in organizing and implementing of the programmes with needs analysis and measuring, evaluating and reporting of the interventions in social cohesion context is an advantage.
- Knowledge of UN and bilateral donor programming.
- Knowledge of financial rules and regulations.
